Message From The President

In 2016, Easter Seals New Brunswick (ESNB) celebrated its 50th anniversary of serving those with disabilities across the province. While there have been some name changes over those 50 years, our mission to ensure those with disabilities can achieve their potential stays the same! ESNB was incorporated in December 1966, as the Canadian Rehabilitation Council for the Disabled (CRCD) New Brunswick Branch, through the amalgamation of the New Brunswick Society for Crippled Children and the New Brunswick Foundation for Poliomyelitis and Rehabilitation. Many new services and programs have evolved over the past 50 years, improving the lives of thousands in New Brunswick.

There has been much to celebrate when looking at Easter Seals NB's history and recent accomplishments. Our collection of film chronicling the early years of ESNB, including the first years of Camp Rotary (1950's and 60) are now preserved in the Provincial Archives. ESNB also produced the video "50 Years of Easter Seals New Brunswick - See the Ability in Disability" which can be seen on YouTube!

Easter Seals is proud to have three of its board members actively involved at the national level, working on Easter Seals Canada's Board of Directors. Rhonda Rubin, an SLP from the Moncton area and a long-time member of the ESNB board, is now Chair of the National Easter Seals Board of Directors. Doug Bridgman, past President of ESNB, is Director at Large and Chair of the Public Affairs Committee, while Glen Hughes is our provincial representative.

Brandon Liston, Easter Seals Canada's national ambassador, continues to exemplify the role of "ambassador". His positive attitude and enthusiasm for helping others have captivated many as he speaks across the country, most recently on public service announcements airing on television and at movie theaters. He definitely emphasizes the "abilities" in all!

As President of the Easter Seals NB Board of Directors, I wish to extend sincere congratulations to the staff of ESNB, our unsung heroes whose dedication and talents allow us to provide the highest level of services to the people of New Brunswick. ESNB could not function without our generous donors, our volunteers, our Rotary Club and government partners, and our board members. Thank you, to all of you. There is much to celebrate and give thanks for in this 50th year, and much more to look forward to over the next 50!

This year, we were very happy to celebrate our 50th anniversary with friends at a Wine and Cheese in December. ESNB produced a video for the event that highlights our organisation's passions over the last 50 years. The video includes historical footage of Camp Rotary from the 1950's and 60's. The original Camp Rotary/Easter Seals NB footage was donated to the provincial archives for preservation, and in return, a digital master copy was provided to ESNB and the Fredericton Rotary Club.

During 2016, ESNB participated in a review process with Social Development and the Occupational Therapists. We are delighted to be moving forward with the implementation of this new equipment loan process, which will improve services to our clients throughout New Brunswick. We continue to support clients through the purchase of equipment in the Personal Services Program. This past year we added 10 bath lifts, along with numerous other items that are a priority for our clients.

I cannot believe that July 2016 marked my 10th year at ESNB. I want to thank the board and staff for all of their best wishes and support. My job is made easier by their obvious commitment and loyalty to our clients. I look forward to working with our partners in 2017 to improve services for people who live with a disability in NB.

FUNDRAISING HIGHLIGHTS

- A new fundraiser started in November: the Friends of We-Care Bowling Challenge took place in Moncton and raised \$4,155 for campership for Camp Rotary.
- □ The Easter Seals **Paper Egg campaign** held in participating stores through March raised a total of **\$13,221.96**, a **36% increase** from the year before. Supporting stores: Lawtons Drugs, Booster Juice, and Red Apple.
